## TRUMP AND VANCE KICK OFF AGGRESSIVE AGENDA

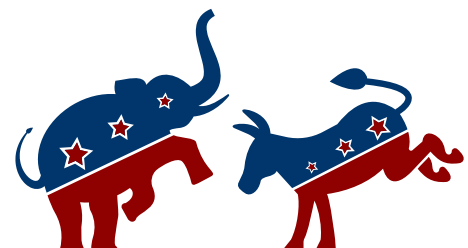

## CONGRESSIONAL LOOK AHEAD

House and Senate Republican Leadership are coordinating to initiate a budget process that will set the stage for a reconciliation package and, potentially, “ONE BIG BEAUTIFUL BILL” covering immigration, energy, and tax policy. With extremely narrow margins in the House, Republicans will need to move gingerly to ensure party unity on the budget resolution, which is the first step in the budget reconciliation process.
